Questionnaires will be **confidential** to the inspectors. We will not reveal your identity, even if the inspectors discuss with the school any issues that you raise. The inspectors will use the questionnaires to help make their judgements.

**Speaking to an inspector**

It may be possible to speak to an inspector during the inspection, for instance at the start of the school day. Inspection administrators will be happy to make the necessary arrangements or to pass on messages to the inspectors if you are unable to speak to them in person. Inspectors will be pleased to receive your comments, but cannot deal with complaints about individual pupils or settle disputes between you and the school.
